- To approve sending Jackie to septic certification training. Motion: Charlotte, Second: Ron
- To approve moving forward with eRate. Motion: Frank, Second: Ron
- To approve moving forward with a study on making the sport of soccer available to students. Motion: Phil, Second: Frank
