### **Meeting Minutes**

June 19, 2023

The child is a sibling of a current BGCS student. The required packet was never received by the deadline and the parent had to submit another packet which caused the 6<sup>th</sup> grade sibling to be placed on the wait list. They questioned the current procedure of the enrollment process and wanted to advocate for their child.

Brief discussion took place on an additional 6<sup>th</sup> grade teacher, and it was decided that one was not needed at this current time.
